Water Agencies Receive Over \$8 Million in Funding from the Department of Water Resources

Grant Funding Supports Water-Use Efficiency Program for More than 60 Communities

**Southern California** - As part of the Department of Water Resources' Urban Community Drought Relief Grant Program, the Inland Empire Utilities Agency (IEUA) and three partner agencies, Calleguas Municipal Water District, Las Virgenes Municipal Water District (LVMWD/District), and Upper San Gabriel Valley Municipal Water District (Upper District), have been awarded grant funding to provide a new water-use efficiency program for select properties in more than 60 communities across the Los Angeles, Ventura, and San Bernardino counties in Southern California. The Turnkey Turf Transformation Project was competitively selected for an award of \$8,474,500 based on its ability to deliver long-lasting water savings within three years or less.

"IEUA is excited to partner with our peer water agencies to provide participating properties with essentially a free landscape makeover," stated IEUA General Manager Shivaji Deshmukh. "We will all benefit from the subsequent water savings while beautifying our communities and are greatly appreciative to have been awarded such critical funding through the California Department of Water Resources."

While water customers throughout Southern California have long had access to a diverse offering of water-use efficiency incentive programs, including rebates for turf conversion<sup>1</sup>, there is still work to be done. The Turnkey Turf Transformation Project is designed to rapidly reduce water demands by complying with the State's Non-Functional Turf Ban by removing large portions of non-functional turf on commercial, industrial, and institutional properties within disadvantaged communities. Helping selected public properties reduce their water use through turf conversion will enhance local water supply reliability and support future regional growth.

Selected sites will receive a landscape evaluation that identifies opportunities to reduce water usage and provides efficient irrigation and plant material recommendations. Following the evaluation, a utility-hired landscape contractor will remove non-functional turf and replace plants and irrigation systems, thus directly reducing water usage and the installation burden on the site owner.

"We thank the Department of Water Resources for their support and look forward to this partnership that will continue to enhance the quality of life across Southern California by ensuring a sustainable water supply for our communities," continued IEUA General Manager Deshmukh.
